AGREEMENT CONCERNING MEMORIAL WALL SPACE RIGHTS

Recitals

Memorial Drive Presbyterian Church (the "Church") has established a Columbarium and Prayer Garden for the use of past or present members, and past and present members of the ordained staff of the Church, and their immediate family members. The ownership and use of the Memorial Wall Spaces in the Columbarium and Prayer Garden are subject to the provisions set forth in this Agreement, the Guidelines for Purchase and Use of Memorial Wall Spaces and the Policies and Procedures of the Columbarium and Prayer Garden Drive Presbyterian Church.

This Agreement is between the Church and the following person(s) or organization(s):

(hereinafter referred to as the "Grantee" whether one or more persons or organizations) with regard to the purchase rights and use of a Memorial Space on the Memorial Wall in the Columbarium and Prayer Garden of the Church. The Church and Grantee are collectively referred to as the "parties."

Agreement

For and in consideration of the mutual covenants herein contained, the parties hereto agree as follows:

- 1. **Purpose.** The Memorial Space forming the basis of this Agreement shall be used for the memorialization of deceased past or present members of the Church, and deceased past or present Ordained staff members of the Church and their immediate families, in accordance with the terms of this Agreement the Guidelines for Purchase and Use of Memorial Wall Spaces in the Columbarium and Prayer Garden of the Church, and the Policies and Procedures of the Columbarium and Prayer Garden of the Church adopted by the Columbarium Committee (hereinafter referred to as the "Committee") and the Session of the Church.
- 2. **Memorial Space.** Grantee hereby purchases certain memorialization rights as set forth herein with respect to the Memorial Wall in the Columbarium and Prayer Garden, and Grantee shall have the opportunity to select the exact location of the Memorial Space from among available and designated Memorial Spaces on the Church's Memorial Wall. Priority in selection of the exact location of the Memorial Space will be based upon the date and time that Grantee has applied and has paid the purchase price in full for a Memorial Space. In the event of a dispute or disagreement as to the date and time of one or more Grantee applications for a Memorial Space, such dispute or disagreement shall be determined by the Committee in its sole discretion, and Grantee agrees to be bound by such determination.
- 3. **Incising of the Memorial Space.** The incising fee per space is included with the full purchase of the Memorial Space rights. This incising shall be in the form approved by the Committee and, consistent with the guidelines set forth in the Policies and Procedures of the Columbarium and Prayer Garden of the Church, and shall contain the name, date of birth, and date of death of the person(s) who is to be memorialized.

- 4. **Purchase Price.** The total purchase price for Memorial Space rights is \$1,000.00, subject to adjustment by the Committee. Such price shall be paid by Grantee as indicated below:
 - a. (Indicate <u>Single Urn</u> or <u>Double Urn</u> purchase) In full; the receipt is hereby acknowledged.
 - b. In installments, as follows:
 - i. (25% minimum) in cash, check, credit or debit card when this Agreement is signed; and
 - ii. Three (3) quarterly installments of ______ each, with the final installment due on or before the following date: ______, which shall be no more than twelve 12 months from the date of this Agreement. Payment of the quarterly installments will be due on or before the following dates:

- c. No correspondence, notice or invoice will be sent to Grantee regarding installment payments, and it is the sole responsibility of Grantee to ensure that the installment timeline is followed. If Grantee fails to meet the above described installment payments Grantee, upon written request, may seek and receive reimbursement for that amount (without interest) which has been paid.
- 5. **Certificate of Ownership.** When the total price of a Memorial Space has been paid, the Church shall issue a written Certificate of Ownership to Grantee, confirming the Grantee's ownership of the Memorial Space rights.
- 6. **Transfer of Memorial Space Rights.** Grantee's rights in the Memorial Space may not be given, transferred, assigned or conveyed in any manner by Grantee to any other person or organization without the prior written consent from the Church. Should the Grantee or Grantee's personal representatives wish to give, transfer, assign or convey the space rights to Grantee's space to another person or organization, such request shall be made in writing to the Committee, which shall approve or disapprove the request at its sole discretion. Grantee shall be bound by such decision of the Committee.
- 7. **Heirs and Administrators.** Grantee understands that this Agreement shall be binding upon each Grantee, his or her heirs, executors, administrators, successors, and assigns.
- 8. **Warranty.** Grantee warrants the authority to execute this Agreement. The Church may request proof of such authority, however, neither the Church nor the Committee shall have any responsibility to inquire further into the authority of the person executing this Agreement or any other instrument relating to this Agreement.

- 9. **Texas Law and Harris County Venue to Apply.** This Agreement and the application or interpretation thereof shall be governed exclusively by the laws of the State of Texas, without regard to conflict of law principles. Any lawsuit arising from disputes under or related to this Agreement shall be brought in the courts of jurisdiction Harris County, Texas, except as provided in the Dispute Resolution agreement below.
- 10. **Dispute Resolution.** If one or more disputes arise in relation to this Agreement, the parties agree that the dispute shall be resolved pursuant to the dispute resolution procedures contained in the Church's Guidelines for Purchase and Use of Memorial Wall Spaces.
- 11. **Application of Policies and Procedures.** This Agreement includes and incorporates by reference all of the terms, provisions and conditions of the Church's Guidelines for Purchase and Use of Memorial Wall Spaces and the Policies and Procedures of the Columbarium and Prayer Garden. Grantee, as evidenced by Grantee's signature below, acknowledges that Grantee has received a copy of the Guidelines and the Policies and Procedures, and has read and understands and accepts the terms and conditions contained therein.
- 12. **Severability.** Each provision of this Agreement shall be independent of and separable from any other provision and the invalidity of a provision of the Agreement shall not affect the enforceability of any of the other terms, conditions or provisions contained therein.
- 13. **Entire Agreement.** This Agreement represents the sole and exclusive agreement between the parties hereto with respect to the matters contained herein and shall supersede any other understanding or agreements with respect to such matters. No amendment shall be effective unless it is in writing and executed by both parties hereto.
